

The editors reserve the right to submit the commercial report for approval to the LKS Editorial Board.

INSERTED ADVERTISING

An insert placed directly inside the journal or in a foil together with the monthly copy of LKS journal.

- One A4 page of printed text up to 10 g in weight price: CZK 2,20
- Each additional page of printed text price: CZK 1,30 (e. g., A4, double-sided print CZK 3,50)
- Catalogues or multi-page printed materials up to 50 g of weight the price will always be calculated individually according to the specifics of the particular printed material
- Insertions of 3D objects the price of the shipment will be calculated individually after sending a sample to the Department of Economics and Services.

The maximum number of insertions of advertising printed materials in one issue of LKS journal is limited. In case of a higher interest, the date of receipt of the order is decisive.
